GUIDELINE FOR ELECTIONS TO THE EXECUTIVE COMMITTEE (EC)

1. Only Life members can contest for any post in the EC.
2. For the posts of President-Elect, Secretary, Treasurer & Editor, the contestant should be a Life Member of the Society with good standing and regular attendance.
3. The candidate should have attended at least 1 annual conference in last 3 years (2015 – 2017).
4. Each contestant shall be proposed by an existing life member and also seconded by another life member (in Nomination Form).
5. The contestants for the post of President-Elect, Secretary, Treasurer & Editor, must have completed at least one term as an EC member in the past.
6. No member of E.C. can take charge of office in any post of the Society without completing the term of existing post.
7. No member is eligible to contest for more than one post in the same election.
8. The President Elect shall automatically become President in the following year. There shall be no election for the post of President.
9. The Executive Committee shall have the right to change the logistics of the election process in the face of exigencies.
